Temporary Investigative Commission (TIC) on Economic Security: results of work in 2023



Closed 5 large schemes which causes significant losses for the state budget: "Duty Free" scheme on tobacco market, several schemes in gambling industry and non-transparent selling of seized russian assets by ARMA.



Additional UAH 15 billion the state budget received last year as a result of closed schemes.

Restart of the ESBU

Adopt the draft law on proper restart of the ESBU.

Support the ESBU restart process.

Prepare and advocate the amendments to the Criminal Procedure Code and other laws for the ESBU effective work after its restart.

Prepare a draft law on special prosecutorial supervision of the ESBU.

Develop and implement a risk-orientation system for the ESBU.

Improve cooperation between the ESBU and other state bodies (NABU, STS, NBU, SCS, SAS and State Financial Monitoring Service).

Fight against illegal tobacco market.

Development of incentives for consumers to detect illegal excise goods.

Control over the raw materials for excise goods.

Implementation of laws to clear the fuel market.

Control over law enforcement bodies regarding their work against illegal markets.

Monitoring financial system operations to prevent illegal gambling.

Adopt the draft law on proper restart of the State Customs Service (SCS).

Support the SCS restart process.

Improvement of the SCS risk management system.

Provide the SCS with the infrastructure development and equipment.

Improve the customs information exchange between Ukraine and other countries.

Open access to customs data, develop and launch BI.Customs.
